### Golf, Drug Testing, and the 2016 Olympics

Every four years something spectacular happens, and this year, it's the Summer Olympics. Commercial Investigations team members are super excited, because golf is included in the line-up! Golf is a big deal for us. We have participated in quite a few charity golf tournaments, some of us go out golfing on the weekends, and it's our President, Michelle's, favorite sport.

While golf is returning to the Olympics, there are controversies around the sport and drug testing. In 2008, the PGA adopted its "Anti-Dope Program" where the PGA officials randomly selected players at tournaments or practice rounds to be tested. With continual amendments to the list of banned drugs, some players taking those drugs previously now faced penalties, resulting in several lawsuits.

Meanwhile, the National Anti-Doping Organization (NADO) policy for Olympic athletes included a "whereabouts test". Starting on May 6, 2016, and going through August 21, 2016, selected elite athletes must report their whereabouts every day to NADO or the International Sport Federation to specify 1 hour each day "where you may be located for testing, at any time, without notice". This is a very intense approach to drug testing, but is aimed to prevent any athlete from having an unfair advantage. One source stated this makes the PGA tour's background screening and drug testing process look like "testing lite". A few professional golfers have spoken out about this testing. Olin Browne stated, "I hate it, I hate everything about it."
